To help apprentices living and employed in the Eastern Bay of Plenty to complete their apprenticeship training and go on to pursue a career in the energy industry.

Eligibility

Candidates for funding support will be:

- A New Zealand citizen or permanent resident.
- A resident (or their guardians) of the Eastern Bay of Plenty (Whakatāne, Ōpōtiki, Kawerau Districts and Kaingaroa Village), i.e. Trust Horizon's geographic area.
- An independent employed apprentice in the energy industry.
- Ineligible for Fees Free (or other funding that covers training costs) and their employer or another funder is not covering the costs of the weekly training fee.
- Able to provide proof of ineligibility for Fees Free support from the Government website or direct notification received.
- Able to provide a copy of their current training course agreement with a recognised training organisation.
- While training, be employed by an employer or have a permanent employment base location (branch) who is located within the Trust's geographic area.

In addition to the above:

- All applicants are eligible to re-apply if continuing study on approved courses.
- Applicants must inform Trust Horizon if they have any other grants or scholarships at the time of completing the application form and at any stage thereafter.
- A successful candidate must be willing to take part in promotional/marketing activity.

Energy Apprentice-Assist Form Preview

Selection Criteria

- Demonstrated commitment to, or interest in, energy-related improvements in efficiency and environmental impact as well as the Eastern Bay of Plenty region.
- General character, leadership potential, and communication and social skills.
- Quality of achievement in studies.
- Preference may be given:
 - to those who have financial hardship; and/or
 - to support efforts towards improving gender equity.
- The selection committee may choose to interview applicants.

Energy Apprentice-Assist

- Energy Apprentice-Assist funding is granted on the recommendation of a selection committee nominated by the Trust.
- Funding is available up to the total annual value of the weekly training fees for a recognised apprenticeship training course that are not covered by Fees Free, other funding or by an employer.
- Funding does not cover tools or indirect costs such as wages, travel, accommodation or food.
- Once approved, the weekly training fee would be paid by Trust Horizon directly to the approved training organisation an eligible apprentice is enrolled with.
